1. Drill 12 1/4" hole to 250' with spud mud. Run and cement 9 5/8" casing. WOC for 12 hours. Pressure test BOP to 1000 PSI.
2. Drill 7 7/8" hole to total depth with low solids, low water loss mud. Run and cement 5 1/2" casing.

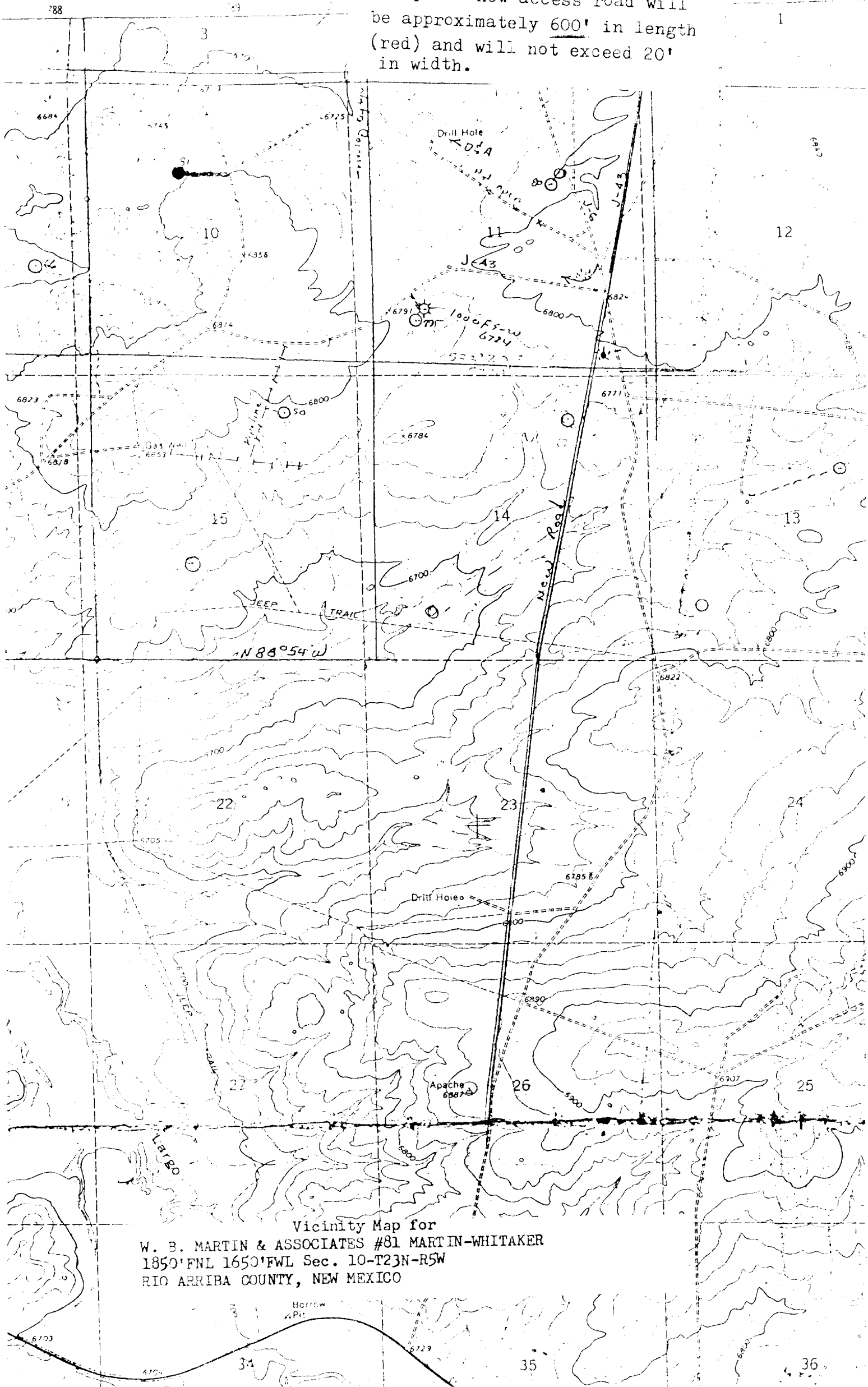
