The well was drilled to a total depth of 2101 ft. Run 8 5/8" surface casing with 285 sacks. 5 1/2" casing set at 2101' and cemented with 240 sacks regular cement. 5 1/2" casing was perforated w/ 30thumberger shots per foot from 2020' to 2070' for a total of 200 shots. Perforations were treated with 28,700 gals. water. 22,500 # sand. After flowing with 24 hours to clean up, well produced gas at rate of 2,288 MCF per day. Well now shut in because of no pipe line connections.
