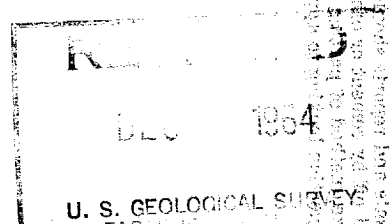
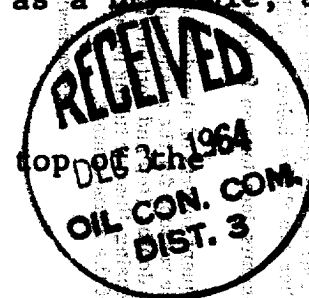

This well was drilled to a T.D. of 1025'. After Sufficient tests and electrical logs run, we request to abandon the well as a Dry Hole, as follows:

1. Load hole with heavy laden mud.
2. Run a cement plug 50' below and 50' above the top of the Gallup formation approximately 500 to 600'.
3. Cap the surface pipe w/regulation marker.
4. Back fill all pits and return the surface back to its natural contour.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
