DETAILS OF WORK

Spotted 35 sack cement plug across perforations 5440' to 5485' and 10 sack plug in top of 5 1/2" casing. Interval between plugs was filled with heavy mud. Cut off well head and welded 4" pipe marker in top of 5 1/2" casing.

Completed plugging well and cleaned up location 12-31-63
