


The elevation of the derrick floor above sea level is 6709 ft.

DETAILS OF WORK

This well has reached its economic limit and is now operating at a loss. Since there are no prospects of returning this well to a commercial producer, we propose to plug the well as follows:

Spot 25 sacks cement plug over perforations 5440' to 5485' and 10 sack plug in top of 5 1/2" casing. Cut off well head and weld 4" pipe marker in top of 5 1/2" casing.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
