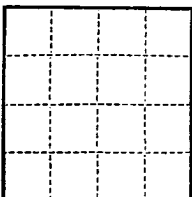

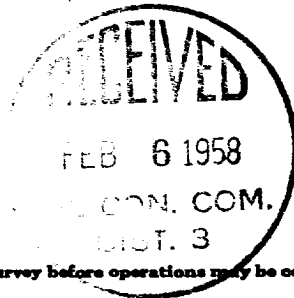

Pumped in 19,400' sand & 20,000 gals. oil & started off. Recovered out 5,600' sand. BOP 2800', brake to 2600'. Max. TP 3600', Min. TP 3400', Inj. rate 30 BPM.
