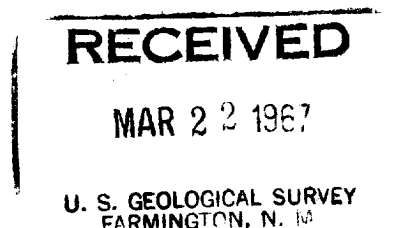

Spud February 26, 1967. Cemented 9 5/8" casing at 114' with 75 sacks. Cemented 4 1/2" casing at 2961' with 200 sacks. Perforated 2875'-2895' with 1 hole / foot. Fracture treated down 4 1/2" casing with 35,000# of 20-40 sand and 39,000 gallons of water. Ran 1 1/2" regular tubing and set at 2891'. Flowed well clean of frac water. Shut in for pressure build up and test.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
