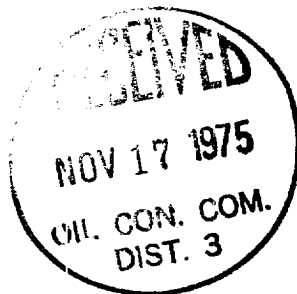

Ran 225 jts., 4-1/2", casing, 10.50 lb. and 11.60 lb., K-55 (7652.20'). Set at 7664.20'. Two stage cementing collar at 3398'. Cemented with: First stage - 650 sacks 50/50 Pozmix "A" with 6-1/4 lbs. Gilsonite per sack, 0.5% CFR-2 and 6.0 lbs. salt per sack. Calculated top of cement - 5600'. Second stage - 160 sacks Halliburton "Light - 12% gel", followed by 50 sacks Class "B" cement. Calculated top of cement - 2500'. 210

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
