As per your request we are asking for a non-standard location for the Apache Hills No. 6. The original was staked 990/N and 1850/W of Section 17-T23N-R3W, Rio Arriba County, New Mexico. Actual drilling site is 1326/N and 1843/W of Section 17-T23N-R3W, Rio Arriba County, New Mexico.

I am at a loss as to why the actual location is 300' from where originally staked unless it was due to extreme wet, muddy conditions during the actual building of the location.

I own the Pictured Cliffs rights in all of Sections 17, 8 and 7. The 300' difference between the original and the actual location in this case should not effect any other operators.
