Elf Aquitaine, Inc. plans to install a rod pump in the subject well and conduct at least a 30 day test of the Dakota Formation prior to completing the well.

The following schedule is anticipated:

0500 hrs Jan 28, 1988 - Released Parker Rig 116 and began moving rig off location. A string of 2 7/8" tubing with anchor had been run to 7200'. The Dakota is open for test from 7544' MD to 9681' MD.

Feb. 10, 1988 - Move in pulling unit to run pump, rods and install pumping unit. Two 400 bbl tanks will be installed temporarily to receive any oil produced.

Feb. 20, 1988 - Began 30 day pump test period.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
