- 3. Article III.D, p.2, lines 39-40 Delete the words "irrespective of the timing of its creation."
- 4. Article IX., p.12, line 63 Delete "1954" and insert in lieu thereof "1986".
- 5. Exhibit "A", Article I. Insert land description as follows:

"Notwithstanding any provision to the contrary in this or any other agreement, any underproduced party shall have the right for a period of two (2) years after the date that gas accounts are balanced by settlement to audit overproduced party's records as to volumes and price of gas from the contract area and any overproduced party shall have the right for a period of two (2) years after the gas accounts are balanced by settlement to audit any underproduced party's records as to volumes".
