The following is an updated report on the Federal Dunn No. 18.

June 10, 1995: Ran 130 joints of 4-1/2", 11.6# casing. Set @ 5,824' KBM. Float collar @ 5,778' and DV tool @ 4,683'. Circulate casing @ TD 5,835'. Cement first stage with 10 barrels gel water, 20 barrels chemical wash, 10 barrels water, 210 sacks 65/35 Poz mix and 100 sacks "G" cement. Drop bomb and open DV tool. Circulate. Plug down at 2:00AM 6/11/95.

June 11, 1995: Cement second stage with 20 barrel water, 870 sacks 65/35 Poz mix and 50 sacks "G" cement. Circulate 250 sacks cement out surface. Plug down @ 7:00AM 6/11/95. TD 5,835'. Rig released at 12:45PM 6/11/95.
