On July 15, 1964 Scott Bros. Drilling Company cemented with 35 sx regular in the 6 1/2" mud filled hole from 650-800 feet covering 75 feet of Mancos shale and 75 feet of Point Lookout sandstone. The surface casing has a cap screwed into it with a 4 foot dry hole marker welded thereon.

Mr. Ben P. Hovey, 1007 Stover Avenue, SW, Albuquerque, New Mexico has surface rights to the drillsite and will install a windmill for obtaining fresh water for his livestock.

Instructions
