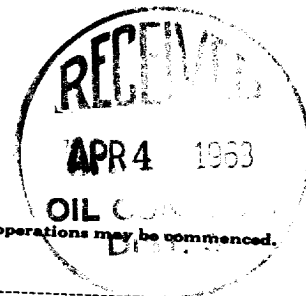

DETAILS OF WORK

Test spudded in the Mancos shale. Set 150' of 5 1/2" casing. Drilled to TL 1503. No fluid encountered in air drilled hole. Log tops: Gallup 396, Senastee ls 1324. Bottomed in lower Mancos at 1503. Set 5 sx cem. at base of surf. casing and filled balance of surf. casing with cement with regulation marker in top.

Hole size 4 3/4".
