DETAILS OF WORK

Pictured Cliffs Test--Drill 12 inch surface hole, set 100 feet of 8 5/8 inch surface pipe circulated to surface with 90 sacks cement. Drill 6 3/4 inch hole to depth of approximately 3200 feet. Run 3200 feet 4 1/2 inch O. D. 9 1/2 lb. casing to total depth, cemented with 100 sacks of cement. Perforate Pictured Cliffs horizon, fracture formation with 30,000 gallons of water and 25,000 lbs. of sand. Clean out, run tubing and complete.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

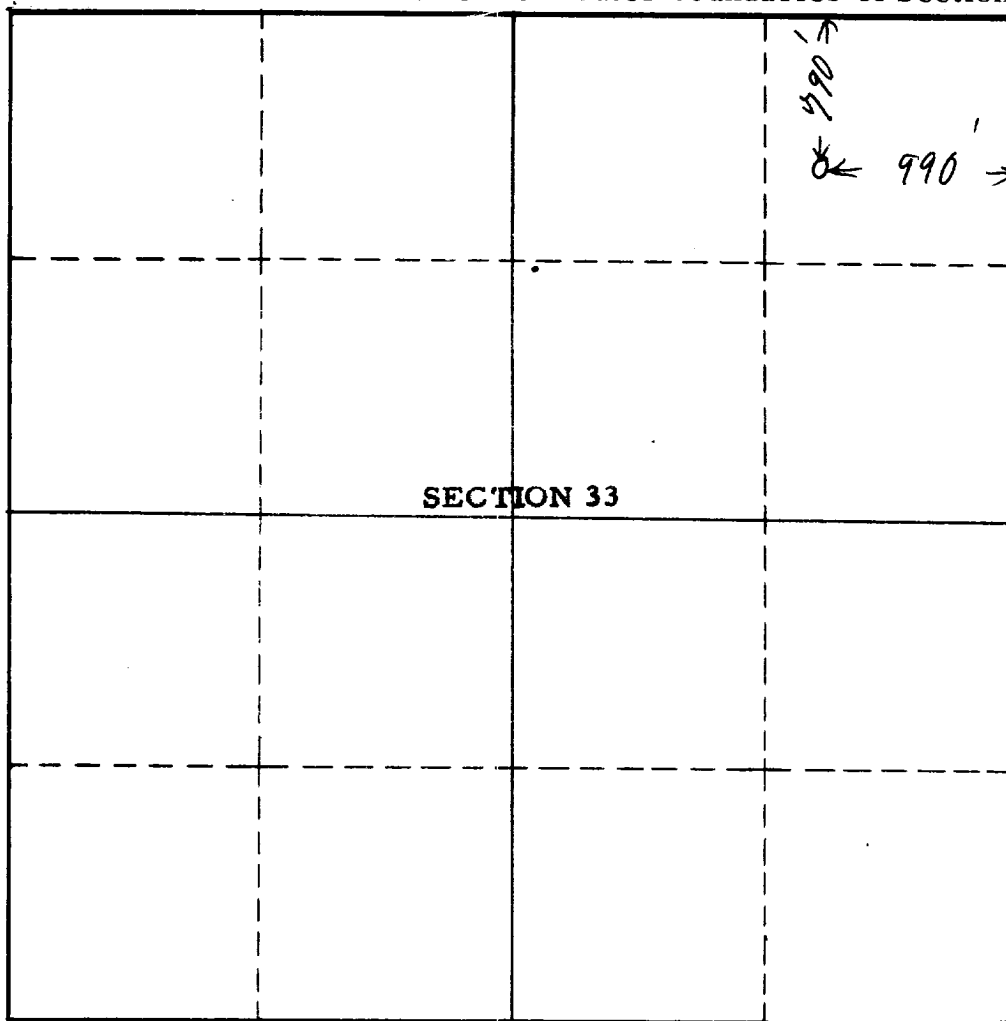
