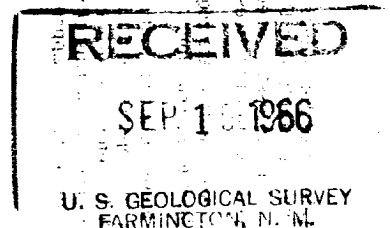

Will perforate and sand- water frac Pictured Cliffs Sand about 10-1-66.

Instructions
