Drilled to 939' with 6 1/2 inch hole. Ran log, to 940 feet. Waiting decision as to whether to complete or abandon.

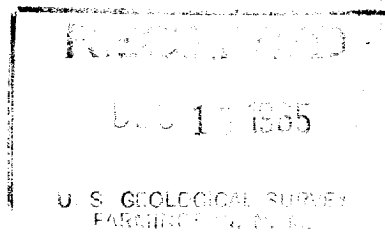

Instructions
