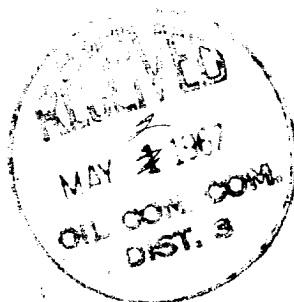

The subject well was drilled to a total depth of 6570' with a 12-1/4" hole. 9-3/8" casing was set at 6370' with a stage tool at 4814'. The first stage was cemented with 800 sacks and the second stage was cemented with 1300 sacks. No cement was circulated on either stage. Drilling resumed with an 8-3/4" hole.

Instructions
