Moved in Big A well service 9-16-74. Pressure tested casing and located a hole in casing at 909'. Unsuccessful in backing off casing below hole.

9-17-74 cut off casing at 993' with chemical cutter. Ran 2390' of 7/8" sucker rods to TD & stacked out. Pulled casing and replaced bad joint and added casing bowl. Tripped in casing and squashed rod string. Rods parted at 901'. Will attempt to fish rods and complete well when rig and other equipment can be scheduled.

Instructions
