Drilled 12 1/4" hole to 260', ran 6 joints 8 5/8" OD 23# L-42 surface casing set at 252' KB cemented with 170 sacks Dowell Class A regular cement plus 2% calcium chloride. Plug down 10:00 PM 30 Aug 71, cement circulated. WOC 12 hours, pressure tested to 700 psig., no pressure drop in 30 minutes. Drilled out from surface casing 10:00 AM 31 Aug 71. Cement weight 16#/gal., mixing temp. 70°F, estimated bottom hole temp. 70°F. Estimated compressive strength at test 1500 psi., at drill out 2400 psi.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
