Shot off and pulled 4 1/2" casing at 270 ft. Perforated Pictured Cliffs 2710-12' squeezed w/25 sx, perforated Ojo Alamo 2400-02', squeezed w/25 sx. Spotted 20 sx. plug 240'-190' at base of surface casing, 10 sx. plug 30'-0' at surface w/standard pipe marker. Location levelled and restored.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
