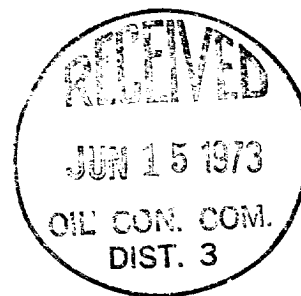

A 12-1/4" hole was spudded at 6:30 p.m., May 26, 1973. The 8-5/8" casing was set at 224' with 200 sacks Class "A" cement with 2% CaCl2 May 27, 1973. The cement circulated. The hole was reduced to 7-7/8" at 224'.

The well was drilled to a TD of 2961' on May 30, 1973 where 4-1/2" casing was set and cemented with 550 sacks 50-50 Pennix, 6% Gel and 2 pounds Tuf Plug per sack followed by 100 sacks Class "c" Nant. The cement circulated.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
