On June 18, 1973 perforated intervals 2746-54, 2762-68, 2778-82, and 2788-94 with 1 SPF. Displaced the hole with treated water and spotted 500 gallons of 15% HCl and displaced at 5 BPM with 2350 psig. Sand-water fraced with 35,000 gallons treated water, 5,000 pounds 20-40 sand, 15,000 pounds 10-20 sand and 10,000 pounds 8-12 sand. Breakdown pressure 2300 psi, maximum treating pressure 2400 psi and average treating pressure 2200 psi. AIR 54 BPM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
