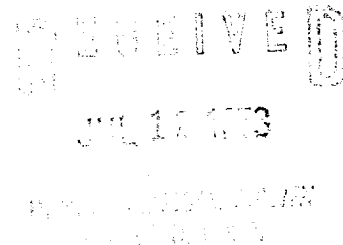

On July 2, 1973, perforated intervals 2657-63', 2671-78', and 2700-10' with 1 SPF. Spotted 750 gallons of 15% HCl. Sand-water fraced with 31,900 gallons treated water (1% KCl and 10 pounds Gel per 1000 gallons water), 5,000 pounds 20-40 sand, 15,000 pounds 10-20 sand, and 10,000 pounds 8-12 sand. Breakdown pressure 1875 psi. Maximum treating pressure 2850 psi and average treating pressure 2650 psi. AIR 49 BPM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
