A 12-1/4" surface hole was spudded at 7:00 p.m. June 29, 1973 and drilled to 207'. The 8-5/8" casing was set at 204' with 200 sacks Type "A" cement with 2% CaCl₂, June 29, 1973. Reduced the hole to 7-7/8" at 207'.

The well was drilled to a total depth of 2872'. The 4-1/2" casing was set at 2872' with 500 sacks Class "C" with 50-50 Pozmix, 6% Gel and 2 pound Tuf Plug per sack and 100 sacks Class "C" Neat, July 2, 1973. The cement circulated.

Instructions
