The subject well has been thoroughly tested and proven to be non-commercial. We propose to plug the well as follows:

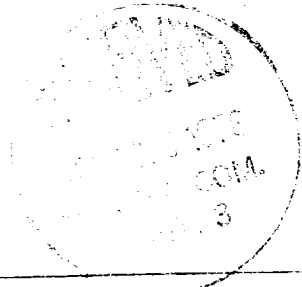
spot cement plug 2350-2200
