Nippled up Shaeffer 7" BOP & tested to 1000 PSI. 7/12/76 drilled out w/6½" bit. 7/18/76 reached TD 1417'. Ran correlation log and directionals survey. Spotted 25 sx temporary plug 85' to 200'. 7/22/76 drilled out cement plug & cleaned out hole for additional logs. 7/24/76 finished logging. S.D. for orders. 8/5/76 moved rig to CPGS - TransOcean Freedom No. 2. Well temporarily abandoned awaiting additional data.

Plans: Well will be plugged & abandoned in accordance w/USGS specifications or will be re-entered for deepening or side track.
