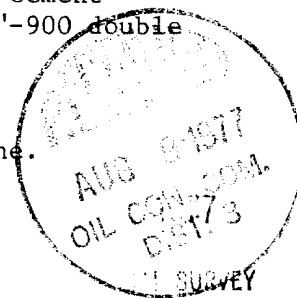

Will drill 9-5/8" hole to 60 ft. and set 60 ft. of 7", 23 lb./ft. casing with 20 sax cement. Will drill 4-3/4" hole to 2700 ft. and run logs. If appears productive will run 2700 ft. of 2-7/8", 6.5 lb./ft., J-55 casing and cement with 150 sax. Will perforate and stimulate as required. Will use 6"-900 double ram blowout preventer.

Note: Gas under development agreement to Northwest Pipeline.

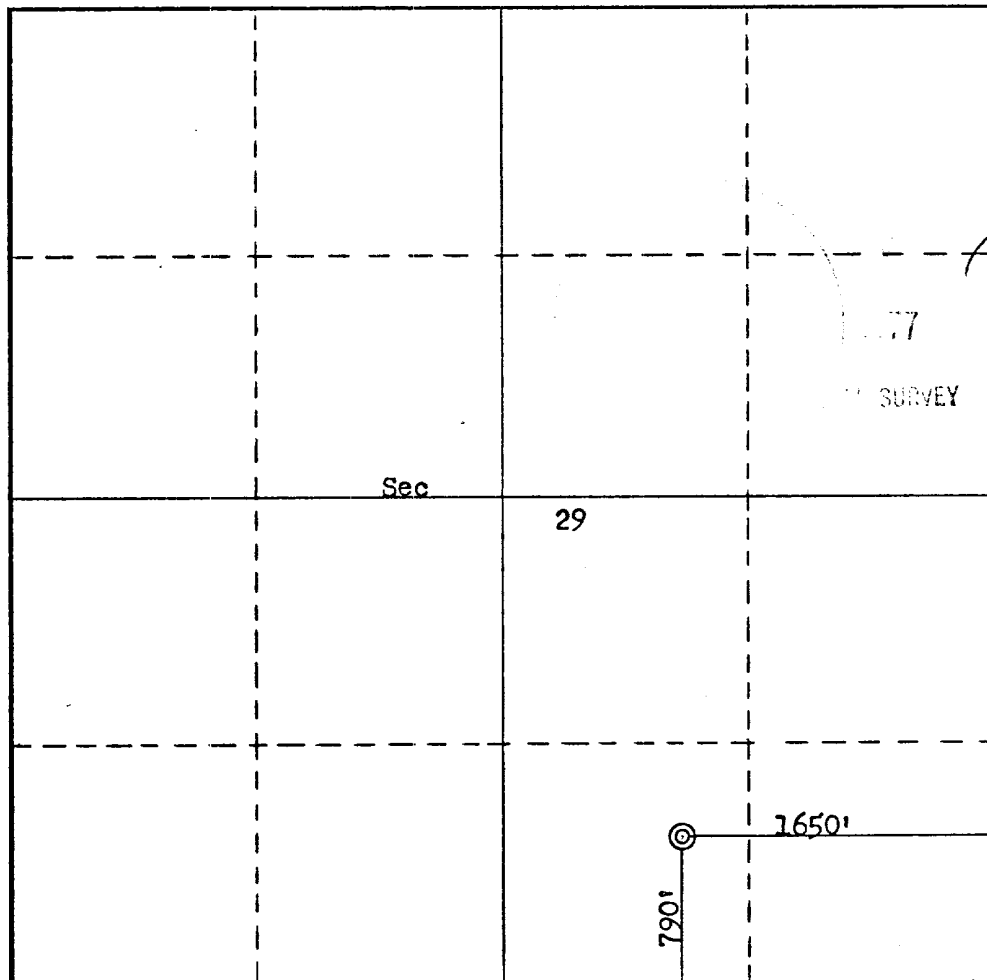

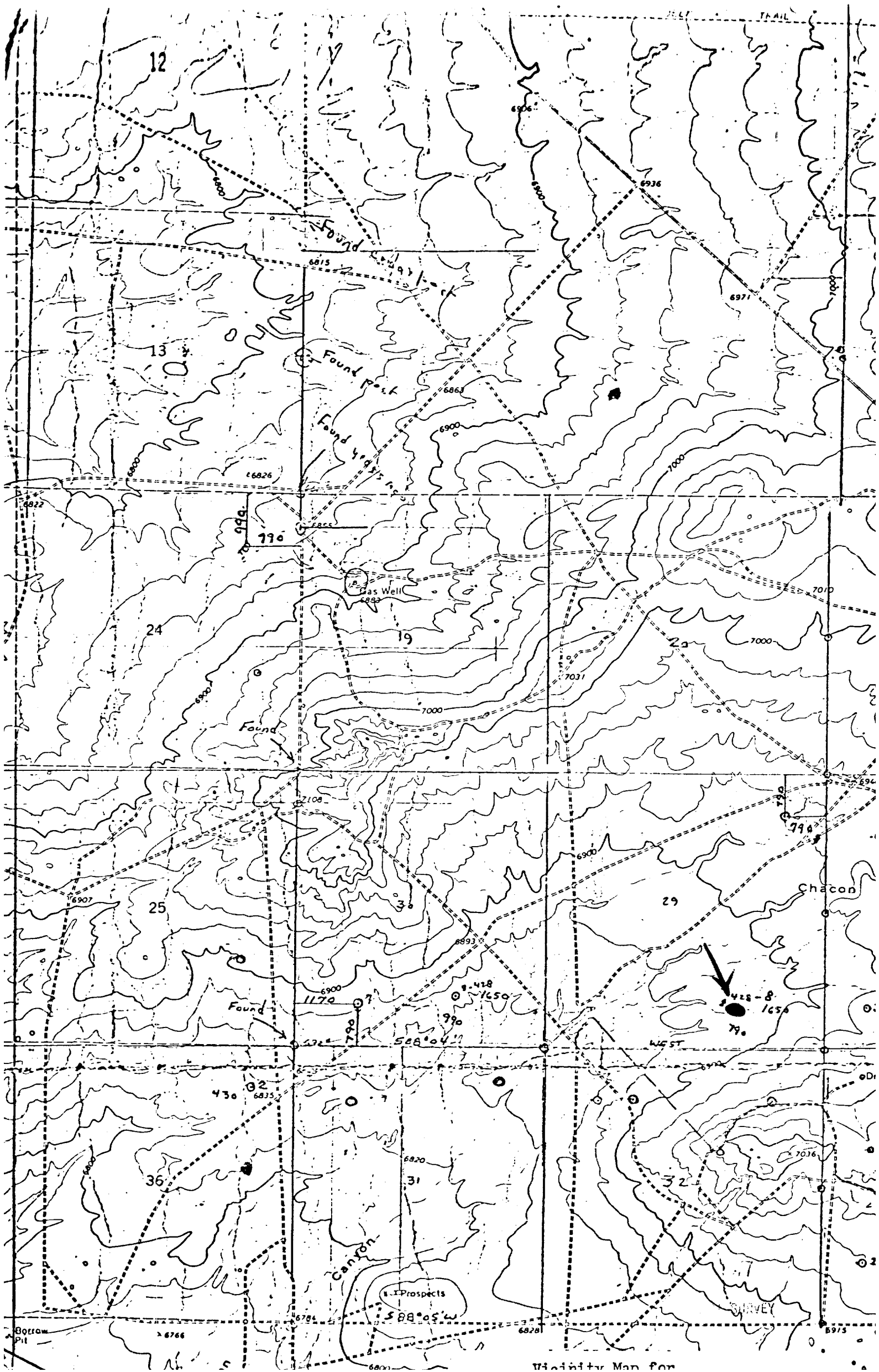
