On 8-17-79, Benson Mineral Group submitted an incomplete report of P & A operations on this well. Therefore, we are now submitting a more complete record of the same.

7-20-79: MI x RU Bedford, Inc. to P x A. Circ hole, spot 15 sx plug 6150 to 5950. Pull tbq to 4450', spot 15 sx plug 4450-4350. Pull 30 jts tbq.

7-21-79: Finish pulling tbq, cut seal plate off rector head. Weld on pull nipple, set jacks.

7-24-79: Work csg. Braden head pulled off of surf. Csg unable to remove slips, work csg.

7-25-79: Move landing slips. MI x RU Go Wireline x shot pipe off at 3956'. Pull 4 1/2" csg.

7-26-79: Pick up tbq x TI hole to 4000', spot 32 sx plug across stub. Pull tbq to 3280', spot 30 sx plug. Pull tbq to 1650', spot 30 sx plug. Pull tbq to 450', spot 40 sx plug, pull tbq.

7-27-79: Set P x A marker x 10 sx surf plug. RD x MO.

Location was cleaned up, waiting on re-seeding.

All above plugs are class B neat cement.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
