THE DRY HOLE MARKER AND SITE RESTORATION ARE IN PROCESS SUBJECT TO WEATHER CONDITIONS AND THE OTHER TWO WELLS BEING PLUGGED. WE PROPOSE TO COMPLETE THE REMAINING WORK BY MARCH 31, 2002.
