(4925 Greenville Ave. Suite 1100 Dallas, TX 75206) has purchased this well from Holcomb Oil & Gas, Inc., effective December 1, 1993, and designated West Largo Corp. as operator. West Largo Corp. has purchased the local Natani Gas Gathering System. Daggett, Inc. will begin surveying right-of-way for hooking the Alamos Canyon wells into the Natani System on 4/12/94. West Largo will be soliciting bids for the pipeline construction work by approximately 5/1/94. Construction of the extension to the gathering system will commence approximately 7/1/94, and should be completed within 2 to 3 months. The wells should be tied in and ready for first production by approximately 10/1/94. West Largo Corp. is herein requesting to have the Shut-In status of the wells extended and the well flow-rate and casing integrity tests postponed until 3/1/95.
