Move in rotary tools. Drill 12 1/4" hole to 100'. Set 100' of new 8 5/8", 23#, K55 casing. Cement with 75 sacks class "B" cement with 2% CaCl. Wait on cement 12 hours. Install 6" 900 Series blowout preventer. Test to 500 psi before drilling out from under surface pipe. Check pipe rams daily and blind rams on trips. Drill 6 1/2" hole to T.D. The geologic name of the surface formation is Tertiary Nacimiento. Gas is expected in the Chacra. All other formations are probably water bearing. Pertinent formation tops are estimated as Kirtland 560'; Fruitland 870'; Pictured Cliff 1430'; Chacra 1790'; and Cliffhouse 2210'. Mud system will be low solids nondispersed. Mud weight 8.8-9.2#/Gal., F.L. 8-10cc, viscosity 30-50 sec./quart. No abnormal temperatures or pressures are anticipated. Logging program will be DIL, FDC/CNL/GR with Caliper Log. Drill stem test will be taken where necessary for evaluation. If productive 4 1/2", 10.5#, K55 casing will be run and cemented w/275 sx. 65/35 Pozmix, 6% Gel, and 10# Gilsonite/sx., followed with 100 sx. class "B" cement w/10% salt. Drilling should require approximately 6 days.



## 1. Existing Roads

The main road to location is that from Counselors Trading Post to Pueblo Pintado, leaving this road approximately 9 miles South of Counselors and using existing side road.

## 2. Planned Access Roads

The access road, to be routed as shown on the attached map, will be approximately 100' long and 18' wide with adequate ditch and water bars.

## 3. Location Of Existing Wells

Existing wells within one mile of location are shown on the attached topographic map.

## 4. Location Of Proposed Facilities

Development of commercial gas production will require separation facilities on the location pad. Equipment and pits will be fenced as required for protection of livestock and wildlife. Above ground facilities will be painted brown or grey to blend in with the surrounding area as specified by the BLM. The disturbed areas no longer needed for operations after well completion will be restored to natural contour and reseeded.

## 5. Location & Type Of Water Supply

To be hauled from Escrito, approximately 25 miles to the North.

## 6. Source Of Construction Materials

Not applicable.

## 7. Method Of Handling Waste Material

All garbage and trash that can be burned shall be burned. All trash that cannot be burned will be contained in a trash pit and covered with a minimum of 24 inches of dirt. All drilling waste such as cuttings, overflows of oil, water, and drilling fluids will be contained in the reserve pit and buried with adequate cover upon completion of operations. The reserve pit will be fenced until cleanup operations are commenced. Toilet facilities will be provided.

8. Ancillary Facilities

No camps or airstrips are proposed for this location.

9. Well Site Layout

See attached diagram.

10. Plans For Restoration Of Surface

Cleanup of the location will commence immediately following the removal of the drilling equipment. The reserve pit will be fenced until restoration operations are commenced. The location will be returned to original contour if the well is not productive. Both the road and location will be reseeded in accordance with BLM specifications.

11. Other Information


This location is on sparsely vegetated sandy land. Vegetation consists principally of sagebrush and native grasses. There is no water source in the immediate area.






