This well was plugged and abandoned on 10/15/96 as follows:

- 1.) Set CIBP @ 1790'. Capped BP with 9 sks class "B" cement.
- 2.) POH to 1505'. Spotted 30 sks class "B" from 1505-1109'.
- 3.) POH to 1038'. Spotted 21 sks class "B" from 1038-761'.
- 4.) TOH. Tied onto bradenhead and squeezed with 15 sks class "B".
- 5.) TIH to 191'. Circulate cement to surface with 21 sks class "B".
- 6.) Cut off wellhead and installed dry hole marker.
