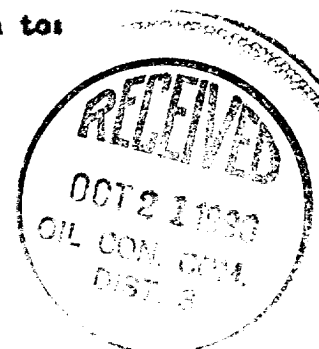
This well was filed for as a 1900' Pictured Cliffs test.

After reaching a depth of 1625 and a close examination of the well cuttings, it appears that in this undrilled township, the Pictured Cliffs zone is going to occur relatively flat to the productive wells located 6 miles to the northwest. It is now anticipated that the objective Pictured Cliffs sand will be penetrated at a depth of approximately 3000 feet.

Therefore, approval is requested to change proposed total depth to:
3100' Pictured Cliffs.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
