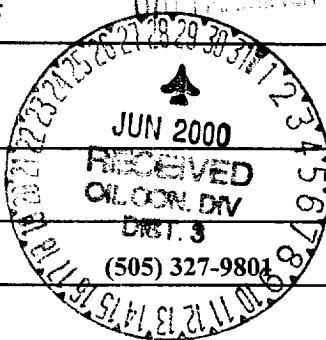

Merrion Oil & Gas proposes to evaluate the subject wellbore for repair and return to production. The well was damaged in May, 1997, by a KCI substitute. Proposed remedial treatments have been ruled out as uneconomic. We propose to re-evaluate a treatment and to determine whether it can be repaired economically. We will need to justify repair costs to co-owners and receive AFE approvals. The evaluation and proposal for well work will be completed no later than August 1, 2000.
