We have not as yet done anything in the way of acidizing, fracturing etc--we are studying the data gathered from a fluorescent cuttings to determine the possibilities of this well being included in the a water flood (polimer) program of the South San Luis Field next door in Section 33. This flood is inactive at present, but plans are being formulated to again produce the oil present here.
