Current open perforations are in the Gallup at 3,920' to 4,520'.

We propose to set a cast iron bridge plug at 3,200'. Squeeze job: Approximately 100 sx cement; set cement retriever; Run Bond Log; If good cement, perf Mancos at 2,940' to 2,950' (10' at 2 SPF); Swab test; then decide if perf Mancos now or later. If Mancos swab tests positive, then perf Mancos at 2,632' to 2,637' and at 2,558' to 2,559'; 2 SPF; Swab test; Run tubing, rods, & pump down to 2,950'.

The estimated date of starting this proposed work and for the other work proposed on the San Isidro #14-4, 12-4, 13-11, 3-16, 5-14, and 12-2 is on or before July 26, 2002. The same rig will be used for the work on all of these wells.
