Gary-Williams Oil Producer, Inc. respectfully requests approval to temporarily shut in the Tayler 30, #8 well for an indefinite time period. Current depressed oil prices make this marginal well uneconomical to produce.

The Tayler 30, #8, well was shut in February and March, 1986. Production in January, 1986, averaged 3.7 BOPD.

Approval for temporary shut in status for this well would prevent premature abandonment of significant recoverable hydrocarbon reserves.
