Gary-Williams Oil Producer, Inc. respectfully requests approval to temporarily shut in the Johnson 4, #14 well for an indefinite time period. Current depressed oil prices make this marginal well uneconomical to produce.

The Johnson 4, #14 was shut in February and March 1986. In January, 1986 the production averaged 1.0 BOPD.

Approval for temporary shut in status for this well would prevent premature abandonment of significant recoverable hydrocarbon reserves.
