West Largo Corp. hereby requests permission to conduct production test on this well. Independent Pipeline Corporation's Natani Gathering System line layed to nearest well (Natani #10, NWNW 14-21N-6W, approx 2.5 miles west. If the well proves economically viable, West Largo Corp. will lay 2" line from well to connect with Natani System.

West Largo Corp. is hereby requesting that the SI status of this well be extended six (6) months until 1/1/96 to allow for testing and construction if necessary. If the well proves incapable of producing hydrocarbons in paying quantities, West Largo Corp. proposes to plug and abandon the well per the procedure described in the associated Sundry Notice dated 6/27/95.

West Largo Corp. has paid the required shut-in minimum royalty payment to extend the lease until May, 1996.
