Gary-Williams Oil Producer, Inc. respectfully requests approval to temporarily shut in the San Isidro 28, #8 well for an indefinite time period. Current depressed oil prices make this marginal well uneconomical to produce.

The San Isidro 28, #8 well was shut in during November, 1985. In October, 1985, production averaged 2.9 BOPD.

Approval for temporary shut in status for this well would prevent premature abandonment of significant recoverable hydrocarbon reserves.
