The Gary-Williams Company respectfully requests permission for suspension of production for the above mentioned well. Current depressed oil prices make this marginal well uneconomical to produce.

There are no known problems with the casing integrity due to the fact that the cement was circulated to surface and the casing is less than 5 years old. Because of the existing condition of the well, GWOP requests that the testing requirements be waived at this time.

In the absence of an approved suspension of production, there may be a premature abandonment of the well and resulting loss of recoverable reserves.
