Gary-Williams Oil Producer requests permission to gather separator gas from the San Isidro 11, #16 located in section 11, T20N, R3W, and the common battery for the San Isidro 12, #2 and San Isidro 12, #4 wells located in section 12, T20N, R3W, for the purpose of re-injection into the San Isidro 13, #11, well located in section 13, T20N, R3W. All well and tank battery locations listed above are in Sandoval County, New Mexico.

This gathering will be accomplished by temporary lines of 2-3/8", 4.7#, EUE tubing (Burst pressure 7,700 psi).

The purpose of the test is to establish an injection pressure. This data will be required for proper compressor sizing.

Gary-Williams Oil Producer also requests a temporary injection permit to inject the collected natural gas (estimated volume: 350-500 mcf) into the San Isidro 13, #11. Gary-Williams proposes to set a double grip production packer above the perforations and inject via the tubing. Perforations are select fire as follows:
