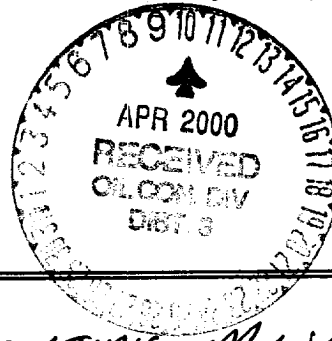

Elm Ridge Resources moved Triple P rig #1 onto the Martin-Whittaker #51 and found rods and pump stuck in paraffin-we freed the rods and pump and converted well to plunger lift. The well is currently producing 3 bopd and venting 5-7 mcf/gpd(est). We have moved a calibrated test meter on the well to chart what it is actually venting.
