Pride Energy Company proposes to lay a one inch pipeline from the San Isidro #7-3 well located in the NW 1/4 of Section 7-T20N-R2W in a Southerly direction for a distance of approximately one-half mile to the San Isidro #7-11 well, located in the SW 1/4 of Section 7-T20N-R2W which is a salt water disposal well, in order to pipe the salt water produced from the #7-3 well to the salt water disposal well being the #7-11 well. This pipeline will be buried in the same trench as the gas pipeline described in Sundry Notice dated July 31, 1997. Also, the Sundry Notice dated July 31, 1997 is to be amended to read "one-half inch" gas pipeline, rather than "one inch" gas pipeline.

Construction will stay within 15' construction zone along the pin-flags in the field.

Pipeline will be reseeded and waterbarred where necessary upon completion of the line.
