9/2/84 Ran 53 joints of 7", 23#, R-3 casing as follows: 1 guide shoe, 1 joint of 7", 23# casing with centralizer in middle of joint, 1 insert float, 1 centralizer on collar, 52 joints 7", 23# casing, centralizer at 1558', cement basket at 1573', and centralizer at 1614'. Set at 2149.91' KB with float collar at 2109.63' KB. Cement by Halco as follows: 255 sx (469.2 cf) 65/35 pozmix containing 6% gel, 10% salt, 1#/sx flocele, followed with 100 sx (118 cf) Class B, 2% CaCl₂. Displace with 80 barrels water. Bump plug with 1000 psi. Release pressure. Float held. Circulate 25 cf of cement to surface. Plug down at 6:45 p.m.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
