Gary-Williams Oil Producer, Inc. respectfully requests approval to temporarily shut in the Chijulla 28, #15 well for an indefinite time period. Current depressed oil prices make this marginal well uneconomical to produce.

The Chijulla 28, #15 well was shut in on March 19, 1986. Production averaged 2.7 BOPD in February, 1986, and in March, 1986, 2.2 BOPD prior to shutting the well in.

Approval for temporary shut in status for this well would prevent premature abandonment of significant recoverable hydrocarbon reserves.
