1. Set 100' cement plug (20 sacks with 25% excess 5 Sacks. total 25 Sacks) at bottom of hole .

2. Fill hole with 9# mud.

3. Set 50' cement plug(10 sacks with 25% surplus 2.5 sacks.)at surface. total 13 sacks.

4. Set 10' dry hole marker (4' in hole 6' above surface.) Cement and weld to surface casing.

Will commence work on March 24, 1992.

Note: In case annulus is not full of cement, annulus to be filled with 50' of cement. (10 sacks.) All evidence of cement and trash will be removed.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
