Pride Energy Company proposes to move oil from the production storage tanks at the San Isidro #15-7 well to the production storage tanks at the San Isidro #12-10 well. Likewise, Pride Energy Company, proposes to move oil from the production storage tanks at the San Isidro #7-3 well to the San Isidro #6-16 well. This proposal is being made because the price per barrel of oil is currently very low and the fact that we're proposing to move the oil allows for the holding of the oil until oil prices increase. Oil prices are anticipated to increase in the next few months.

This proposal has been discussed today with and verbally approved by Mr. Allen F. Buckingham of the Minerals Division of the Bureau of Land Management in Albuquerque, New Mexico.

CONDITIONS OF APPROVAL ARE (as given to Matt Pride over the telephone on June 25, 1998):

1. Oil storage tanks must be gaged before and after removal of oil from tank.
2. Oil storage tanks being utilized for storage of oil from a different lease must be gaged before the oil is pumped into the tank and immediately upon completion must be gaged again. Accurate records must be kept of all tank gagings.
3. The oil truck hauler must have proper documentation when moving the oil from one lease to another.
4. Appropriate entries must be made on all Form 3160s, Monthly Report of Operations, for each well and lease involved before submission to the Minerals Management Service.
