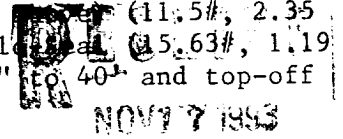

On 10/10/93, well spudded at 12:30 AM
 On 10/11/93 and 10/12/93, set 13-3/8", 61#, K-55, ST&C casing at 240'; Cemented with 320 sx CL B + 3% CaCl₂. Good returns to surface (37 bbls). Tested BOP's and casing.
 On 10/19/93, log with DIL and dipmeter at 3520'. Started directional drilling at 3520'.
 On 10/30/93, set 7-5/8", 26.4#, K-55 & N-80, LT&C casing at 4555' MD, 4229.7' TVD.
 Parasite tubing attached at 2561' (1-1/2", 2.76#, CW-55, IJ 10rd).
 Cemented as follows:
 Stage #1 Cement (4555' to 2644' DV Tool): 30 bbls of water plus 15 bbls of Surebond plus 40 bbls of water followed by 95 sx Super B (47 lb/sk Super B + 18.5 lb/sk Pox A + 18.5 lb/sk CSE + 5% salt + .25 lb/sk Cello-Seal). (11.5#, 2.39 cu ft/sk) followed by 310 sx Cl B + 3 lb/sk Hi-Seal 2 + 10% salt + 10% Thixad + .25 lb/sk Cello-Seal (14.7#, 1.57 cu ft/sk).
 Stage #2 (2644' DV Tool, to surface): 895 sx of Super B (same as (11.5#, 2.35 cu ft/sk) followed by 170 sx Cl B + 2% CaCl₂ + .25 lb/sk Cell (11.5#, 2.35 cu ft/sk). Good cement returns to surface (26 bbls). Run 1" to 40" and top-off with 7 sx of Cl B + 2% CaCl₂. Tested BOP's and casing.
 On 11/1/93, drilled below 7-5/8" casing with a 6-1/2" bit.
 NOTE: On 10/20/93, water well completed at 670', producing 24 GPM.
